I'w drafod yn ein cyfarfod nesaf. / *Received a request from the owners of Frondeg to formally use the rear access to their garden as an established second entrance. Clr. M Williams explained that there could be an existing easement in place. To be discuss at our next meeting.*
- 12.5 Mae grant Amgylcheddol a Gwella o £5k ar gael i denantiaid Tai Gyngor ar gyfer prosiectau amgylcheddol i wneud y gymuned yn fwy diogel a thaclus. Dyddiad cau 29/03/19 / *Environmental and Improvement grant of up to £5k is available to Council House tenants for environmental projects to make the community safer and tidier. Closing date 29/03/19*
