**1. Ymddiheuriadau/Apologies** - Cyng.Maldwyn Williams a Myrddin Roberts

**2. Cofnodion / Minutes** - Penderfynwyd derbyn y cofnodion o'r cyfarfod a gynhaliwyd ar 17ddeg o Fehefin fel rhai cywir gan Martin Hennessey, eiliwyd gan Rhian Hughes / *Minutes of the previous meeting held on 17<sup>th</sup> June were accepted as accurate by Martin Hennessey, seconded by Rhian Hughes.*

**3. Datgan Diddordeb/Declaration of interest**

**4. Materion yn codi / Matters arising**

- 4.1 Disgrifiad Swydd y Clerc - Esboniodd y Clerc ei fod wedi tynnu ei lythyr ymddiswyddo yn ôl. / *Clerk Job Description - Clerk explained that he has withdrawn his letter of resignation.*
- 4.2 Y tri chais fforddiant a dderbyniwyd gan SP Energy- Comin Llaniestyn, Maes Chwarae Plant a gwyro ger Jalna a Decorah. Esboniodd y Clerc, yn dilyn cyngor gan syrfëwr tir, nad yw iawndal am unrhyw ddifrod i dir yn dilyn unrhyw waith ar gael, ond y dylid ei godi'n syth gydag SP Energy er mwyn unioni unrhyw ddifrod. Mae methu â gwneud hynny yn caniatáu amser a natur i gymryd drosodd. Daethpwyd i'r casgliad i arwyddo'r ceisiadau fforddfraint. / *Three Wayleave applications received from SP Energy- Llaniestyn Common, Playfield Field and diversion near Jalna and Decorah. Clerk explained that following advise from a land surveyor, that compensation for any damage to land following any work is not available, but should be raised immediately with SP Energy in order to rectify any damage. Failure to do so, allows time and nature to take over. It was concluded to sign the wayleave applications.*
- 4.3 Lloches bws gyferbyn a Phonc y Felin wedi'i atgyweirio. / *The roof of the bus shelter opposite Ponc y Felin has been repaired.*
- 4.4 Arwyddion Ystâd Tai - gwaith ar y gweill gyda'r contractwr i godi'r arwyddion newydd ond y bydd yn cymryd peth amser / *Housing Estate signs - work is in hand with the contractor to erect new signs but it will take some time*
- 4.5 Banc bwyd - adroddwyd fod y banc bwyd yn cael ei wasanaethu'n dda yn Llanddona. Cytunwyd i ddiolch i waith y gwirfoddolwyr lleol sy'n gweithio ar y prosiect hwn / *Food Bank - it was reported that the food bank is well serviced in Llanddona. It was agreed to thank the work of the local volunteers that are working on this project.*
- 4.6 Maes Chwarae Plant - eglurodd y Clerc, o ran Covid 19, y bydd ardaloedd chwarae plant yn ail-agor i'r cyhoedd ar 20/07/20 ond cododd bryderon ynghylch monitro a glanhau'r offerion. Clerc i greu asesiad risg ac arwyddion / *Childrens Play Area - the Clerk explained that with regards to Covid 19, Children's Play area's will re-open to the public on the 20/07/20 but raised concerns regarding the monitoring and cleaning of the equipment. Clerk to create risk assessment and signs.*
- 4.7 Pwrcasu mainc ar gyfer y fynwent newydd. Dywedodd y Clerc fod un teulu wedi dangos diddordeb mewn cyfrannu at fainc / *Bench for the new cemetery. Clerk explained that one family have shown an interest in donating towards a bench*
- 4.8 DeFib -mae aelod wedi cytuno i drafod hyn yng nghyfarfod nesaf Cynghair Seiriol / *DeFib - a member has agreed to discuss this at the next Seiriol Alliance meeting.*

**Adrodd gan Gyngorydd A Roberts / Report by Councillor A Roberts:-**

- Mannau chwarae i blant- esboniwyd bod llawer o waith wedi'i wneud i agor ardaloedd chwarae ac mae gwybodaeth bellach yn ddyledus gan y Cyngor Sir. Esboniwyd ymhellach bod Cyngor Cymuned Cwm Cadnant yn ystyried agor y neuadd bentref lleol. Clerc i gysylltu gydag ein cwmni yswiriant / *Children's Play Areas - explained that a lot of work has gone in to opening play area's*

and further information is due from the County Council. Further explained that Cwm Cadnant Community Council is considering opening the local Village Hall. Clerk to consult with our insurance company.

- Tai Fforddiadwy - mae cyfarfod wedi'i gynnal i edrych ar bolisiau ac ati. Disgwylir canlyniad yr wythnos hon. Dywedodd aelod fod llawer o drafodaethau'n cael eu cynnal yn ddiweddar ar y cyfryngau cymdeithasol ynghylch polisiau cynllunio gyda llawer o ymatebion yn cael eu cyflwyno / *Affordable Housing - a meeting has taken place to look into policies etc. Outcome is expected this week. A member stated that there was a lot of discussions recently on social media regarding Planning Policies with many responses submitted.*
- Bydd marciau a rhwystrau stryd yn cael eu gosod yn Stryd y Castell Biwmares er mwyn cynyddu'r ymbellhau cymdeithasol / *Street markings and barriers are to be installed in Castle Street Beaumaris in order to increase social distancing*
- Teimlir bod y Cyngor Sir yn gywir wrth agor ysgolion am un wythnos, mae'r adborth yn gadarnhaol ac mae'r plant wedi mwynhau bod yn ôl / *It is felt that the County Council was correct in opening Schools for one week, feedback is positive and the Children have enjoyed being back.*

## **8. UFA/AOB**

- 8.1 Mynegwyd pryder nad oes gennym ond mewnbwn gan 2 o'n tri chynghorydd sir yn ein cyfarfodydd rhithwir / *Concern was raised that we only have input from 2 of our three County Councillors at our virtual meetings.*
- 8.2 Ffordd Glanrafon i Langoed wedi cael ei ail-wynebu / *Glanrafon to Langoed road has been resurfaced.*
- 8.3 Mynegodd un Aelod bryder nad yw pellhau cymdeithasol yn digwydd mewn prif siop ym Miwmares. Ni wneir unrhyw gyfri ar y rhif sy'n mynd i mewn i'r siop unrhyw bryd. Cynghorydd. A Roberts i godi'r mater / *A member raised concern that Social Distancing is not happening in a main shop in Beaumaris. No count is made on the number entering the shop at any time. Cllr. A Roberts to raise the issue.*
- 8.4 Mynegodd yr Aelodau bryder ynghylch y diffyg arwyddion ar gyfer y gwaith sydd i ddod gan Dŵr Cymru ar hyd lôn Hafoty. Dywedodd Cyng. A Roberts fod y Cyngor Sir wedi bod yn gwrthio'r cwmni i leihau'r cyfnod y mae'r ffordd ar gau / *Members raised concern regarding the lack of signs for the*

*forthcoming works by Welsh Water along Hafoty road. Cllr. A Roberts stated that the County Council have been pushing the company to reduce the period that the road is shut.*

- 8.5 *Mynegodd aelod bryder ynghylch y gordyfiant o'r gwrych sydd ger Minffordd a Tanbryn, mae angen ei dorri'n ôl ar frys. Cyng. A Roberts i godi'r mater gyda'r Cyngor Sir / A member raised concern about the amount of overgrowth from the hedge by Minffordd & Tanbryn, is in uregnt need of cutting back. Cllr. A Roberts to raise the problem with the County Council.*
- 8.6 *Dywedodd y Clerc fod y gwaith yn cael ei wneud ar dir comin y Rhos, gan dorri'r ymylon yn ôl a rholio'r eithin. Mynegodd un Aelod bryder ynghylch defnyddio "round up " mewn ardal SSI / Clerk reported the work to be carried out on the Common land of the Rhos, cutting back the verges and rolling the gorse. A member raised concern about the use of "Round Up" in an SSI area*
- 8.7 *Cododd aelod bryderon ynghylch faint o faniau a wersyllwyd sydd ar y traeth yn Llanddona. Dywedodd Cyng. A Roberts y gobeithir y bydd cyfarfod yn cael ei drefnu gan y Cyng. C Jones er mwyn trafod y broblem hon / A member raised concerns about the amount of camper vans of the beach in Llanddona. Cllr. A Roberts stated that a meeting will hopefully be arranged by Cllr. C Jones in order to discuss this on-going problem.*
- 8.8 *Nodwyd bod preswlydd yn gosod hen lyfrau a hongian sgarffiau yn y gysgodfa'n bws. Oherwydd y firws Covid argymhellwyd siarad â'r preswlydd gan ofyn i symud yr eitemau / It was noted that a resident is placing old books and hanging scarfs in the bus shelter. Due to the Covid virus, it was recommended to speak to resident requesting that the items are removed.*
