4.1 Arolwg Coed - Mae'r coed a nodwyd yn flaenorol fel risg uchel wedi'u torri lawr i gyd, gyda'r eithriad o'r goeden sydd wedi'i lleoli wrth ymyl y Neuadd. Bydd y Clerc yn cysylltu â'r contractwr ynglŷn â'r mater hwn. / *Tree Survey - The trees previously identified as high risk have all been cut down, with the exception of the tree located opposite the Hall. The Clerk will contact the contractor regarding this matter.*

- 6.1 Mae Grŵp Natur Seiriol wedi ymgymryd â gwaith torri ar y tir cyffredin o flaen Pentre' Bolion. Mynegodd yr aelodau bryder bod angen mwy o waith yn y lleoliad hwn./ *The Seiriol Nature Group has undertaken cutting work on the common land opposite Pentre Bolion. Members expressed concern that further work is required at this location.*

- 7.1 Grugfa - ar ôl ein cais am wybodaeth gan ein cyfreithiwr i'n pryder, trafododd yr aelodau'r amodau diweddaraf. Cytunodd Cyng. A Roberts i godi mater rhwystro ar y llwybr cyhoeddus gyda'r Cyngor Sir./ *Following our request for information from our solicitor to our concern, members discussed the latest conditions. Clr. A Roberts agreed to raise the matter of obstruction on the public footpath with the County Council.*
