7. Tir Commin / Common Land

7.1 Grugfa - trafododd yr aelodau'r wybodaeth a dderbyniwyd oddi wrth ein cyfreithiwr a chytunwyd yn unfrydol i addasu / *Members discussed the*

information received from our solicitor and unanimously agreed to amend.

- 7.2 MOU - cynhaliwyd cyfarfod safle ar 13/05 gyda'r Cyng. M Williams, M Griffiths ynghyd ag S Hunt ac B Scholes a swyddogion o'r Cyngor Sir i drafod y Memorandwm ynghylch rheoli tir comin yn Llanddona a Rhos Llaniestyn / *A site meeting took place on 13/05 with Clr. M Williams , M Griffiths together with S Hunt & B Scholes and officers from the County Council to discuss the mou regarding the management of common land in Llanddona and Rhos Llaniestyn*
- 7.3 Tŷ Mawr/Cae Refail - trafododd yr aelodau bryder gan berchnogion Cae Refail ynghylch mynediad i'w dreif o'r tir comin gyferbyn â Tŷ Mawr / *Members discussed the concern from owners of Cae Refail regarding access to their drive from the common land opposite Ty Mawr.*
- 7.4 Nodwyd bod dau blanhigyn wedi'u plannu ar dir ger y gwrych ffin Pensarn a Mynydd Crafoed / *It was noted that two plants have been planted on land near the boundary hedge at Pensarn and Mynydd Crafoed.*
- 7.5 Yn dilyn trafodaeth ynghylch tir comin, pwysleisiodd yr aelodau'r angen i'r Cyngor Cymuned greu Polisi Hawddfaint / *Following discussion regarding common land, members emphasised the need for the Community Council to create an Easement Policy.*

- 9.2 Esboniodd y Cyng. G Hughes y digwyddiad hyfforddi diweddar a fynychwyd ar 05/05/26- Dealltwriaeth o'r Gyfraith / *Clr G Hughes explained the recent training event attended on 05/05/26- Understanding the Law.*

10. Grant Balchder yn y Gymuned / Pride in the Community grant

- 9.1 Trafodwyd Grant Balchder yn y Gymuned o £9,642 wedi'i fwriadu ar gyfer cyllid cyfalaf yn unig. Cytunwyd ar y cyd i dderbyn y grant, gyda'r Clerc i ymateb erbyn 11/05/26. Awgrymwyd y gellid defnyddio'r grant tuag at yr ardal chwarae i blant, arwyddion cyflymder a meinciau ar gyfer y cysgodfeydd bysiau / *Discussed the Pride in the Community grant of £9,642 intended for capital funding only. It was unanimously agreed to accept the grant, Clerk to respond by 11/05/26. It was suggested that the grant could be used towards the children play area, speed signs and benches for the bus shelters.*
