2. Cofnodion cyfarfod misol 13/05/26/Minutes of monthly meeting 13/05/26

Derbyniwyd cofnodion y cyfarfod blaenorol a gynhaliwyd ar 13 ddeg Mehefin fel rhai cywir gan Barbara Williams, eiliwyd gan Tony Jones / *The minutes of the previous meeting held on 13th May were accepted as accurate by Barbara Williams, seconded by Tony Jones.*

3. Datgan diddordeb rhagfarnol / Declaration of prejudicial interest

3.1 Datganodd y Cyng. G Hughes fuddiant personol a rhagfarnllyd yn gais cynllunio HHP/2026/109 oherwydd eu bod yn aelod o'r teulu ac yna gadawodd y cyfarfod yn ystod y drafodaeth ar yr eitem, heb gymryd rhan yn y drafodaeth. / *Cllr G Hughes declared a personal and prejudicial interest in Planning Application HHP/2026/109 due to being a member of the family and withdrew from the meeting during consideration of the item, taking no part in the discussion.*

5. Adrodd gan y Cynghorwr Sir / Report by County Councillor

5.1 Ymddiheurodd y Cyng. A Roberts nad oedd yn gallu mynychu ein cyfarfod blaenorol oherwydd gwrthdaro cyfarfodydd./ *Clr. A Roberts apologised that he was unable to attend our previous meeting due to a clash of meetings.*

5.2 Cynnig Ardoll Ymwelwyr - mae'r Cyngor Sir Ynys Môn yn ceisio mewnbwn gan randaliad - dyddiad cau 13/07/2026. Mynegodd yr aelodau bryder ynghylch y dreth gan for twristiaeth yn bwysig iawn i'r ynys / *Visitor Levy proposal - IOACC is seeking input from stakeholders - closing date 13/07/2026. Members expressed concern with the levy as tourism is very important to the island.*

- 5.3 Mae'r Cyngor Sir bellach yn dychwelyd i fusnes fel arfer yn dilyn yr etholiad a'r eisteddfod / *The County Council is now returning to business as usual following the election and eisteddfod.*
- 5.4 Mae problemau gyda phorth cynllunio newydd IOACC bellach wedi'u datrys / *Issues with the new IOACC Planning Portal have now been resolved.*
- 5.5 Esboniodd Alun fod yr adran Briffyrdd wedi ailddosbarthu torri ffyrdd dosbarth 3 a 4 o 3 i 2 waith y flwyddyn oherwydd toriadau cyllid / *Alun explained that the Highways department have reclassified the road cutting of class 3 and 4 roads from 3 to 2 times a year due to funding cuts.*
- 5.6 Atgoffwyd Alun am arwydd Llanfihangel sydd heb ei godi eto / *Alun was reminded about the Llanfihangel sign thats still not erected.*

6. Grŵp Natur Seiriol / Seiriol Nature Group

- 6.1 Nododd yr aelodau fod coed helyg yn tyfu'n gyflym ar y tir comin gyferbyn â Neuadd y Pentref a bod angen ei drin / *Members noted that the willow is growing quickly on the common land opposite the Village Hall and needs to be treated.*

7. Tir Commin / Common Land

- 7.1 Nodwyd bod y gwartheg yn pori ar dir comin Rhos / *It was noted that the cows are grazing the Rhos common.*
- 7.2 Grugfa - cytunodd yr aelodau y dylai'r Clerc ddilyn y cynnydd / *Members agreed that the Clerk to follow up on progress.*
- 7.3 Mynegwyd pryder ynghylch parcio cerbyd ar dir comin ger Glangors, o bosibl oherwydd y cais cynllunio diweddaraf / *Concern was raised regarding the parking of a vehicle on common land near Glangors, possibly due to the latest planning application.*
- 7.4 Mynegwyd pryder ynghylch y gwaith adeiladu sy'n cael ei wneud yn 3 Pensarn a'r difrod i dir comin / *Concern was raised regarding the building work being carried out at 3 Pensarn and the damage to common land.*

8. Awdit / Audit 2025/2026

- 8.1 Esboniodd y Clerc ganlyniadau'r Archwilydd Mewnol. Yn dilyn esboniad llawn, cytunwyd yn unfrydol i dderbyn yr adroddiad a chymeradwyo'r Datganiad Llywodraethu Blynnyddol. Y Clerc i'w baratoi a'i gyflwyno i Archwilio Cymru.
/ The Clerk explained the outcomes from the Internal Auditor. Following a full explanation, it was unanimously agreed to accept the report and approve the Annual Governance Statement. Clerk to prepare and submit to Welsh Audit.

9. Hyfforddiant (wedi cylchredeg) / Training (circulated)

- 9.1 Cylchlythyr amserlen hyfforddi wedi'i dosbarthu gan y Clerc. Pwysleisiodd y Clerc yr angen i Gynghorwyr gymryd rhan mewn hyfforddiant y gellir ei drefnu fel grŵp gan OVW / *Training - training*

timetable circulated by the Clerk. The Clerk emphasised the need for Councillors to participate in training which can be arranged as a group by OVW.

10. Grant Balchder yn y Gymuned / Pride in the Community grant

- 9.1 Esboniodd y Clerc gam nesaf y grant gan fod Atodiad B i'w gyflwyno erbyn 30/06/2026. Trafododd yr aelodau'r opsiynau ar gyfer offer chwarae, arwyddion cyflymder sy'n fflachio a phlannwr carreg. Penderfynwyd hefyd geisio grantiau pellach tuag at offer meysydd chwarae./ *The Clerk explained the next stage of the grant in that Annex B is due to be submitted by 30/06/2026. Members discussed the options of play equipment, flashing speed signs and a stone planter. It was also decided to seek further grants towards play ground equipment*

11. Traeth / Beach – Andy Godber

- 11.1 Esboniodd Andy Godber fod yr oedi i'r prosiect ardal traeth a drafodwyd yn flaenorol oherwydd bod yr Adran Briffyrdd yn ymchwilio i berchnogaeth tir. Mynegodd yr aelodau eu siom ynghylch hyd yr oedi a'r diffyg cynnydd ar y mater / *Andy Godber explained that the delay to the previously discussed beach area project was due to Highways investigating land ownership. Members expressed their disappointment at the length of the delay and the lack of progress on the matter.*
- 11.2 Trafododd yr aelodau'r cynllun gan C Slade i greu bwnd pridd i achub eu tir ar y traeth rhag difrod pellach. Barn yr aelodau yw bod yr ardal hon yn cael ei chadw ar agor ac yn glir i'r cyhoedd ei defnyddio. Cytunwyd y byddai A Godber yn ymchwilio i hawliau hanesyddol a'r rhwymedigaethau cyfreithiol / *Members discussed the plan from C Slade to create an earth bund to save their land on the beach from further damage. It is the members opinion that this area is kept open and clear for public access. It was agreed that A Godber would investigate historic rights and legal obligations.*

- Increase in traffic on this narrow lane
 - Obstruct with the public footpath and bridleway
 - Crosses common land – will need an easement
 - There is sufficient parking at the front of the property
